#### Introduction

The Multi-Year Accessibility Plan outlines the Township's strategy to prevent and remove barriers and to meet the requirement of the Integrated Accessibility Standard Regulation.

The 2019 - 2024 Multi-Year Accessibility Plan is an amendment to the original 2006 Multi-Year Accessibility Plan along with the amendments completed in 2008, 2010 and 2014.

This Multi-year plan is a fluid document and framework which provides high level deliverables and activities over the next several years. The Plan will be reviewed annually by Township staff, members of the public and persons with disabilities, whenever possible, and updated to meet that year's projects and priorities.

An annual status report will be provided to Council regarding the Township's accessibility compliance and progress. Every five years the Multi-Year Accessibility Plan will be subject to a full review and update.

Under the requirements of the Accessibility for Ontarians with Disabilities Act, 2005 (AODA) the Township of Alnwick/Haldimand is not required to have a formal Accessibility Advisory Committee, having a population of less than 10,000 residents. As required under the Integrated Accessibility Standards Regulation (IASR), the Township does consult with person with disabilities for the review of the Multi-Year Accessibility Plan.

Under the definitions of the Integrated Accessibility Standards Regulation, the Township of Alnwick/Haldimand is a small designated public sector organization.

The Multi-Year Accessibility Plan contains compliance guidelines related to the requirements of the Integrated Accessibility Standards Regulation. Specific operating and capital projects to improve accessibility within and access to, all municipal buildings and facilities are identified in the Plan.

#### **About the Township of Alnwick/Haldimand**

As prescribed by the Ministry of Municipal Affairs and Housing Order made under Section 25.2.(6)(b) of the Municipal Act, dated June 9th, 1999 and being effective January 1, 2001, The Corporation of the Township of Haldimand amalgamated with The Corporation of the Township of Alnwick to become The Corporation of the Township of Alnwick/Haldimand.

Alnwick/Haldimand Township is a growing community with a permanent population of 6,617 (2011 Census). The highest density of population is situated on the north shore of Lake Ontario and along the south shore of Rice Lake. The Township is 398.57 sq. kilometres in size and has approximately 404 kilometres of Municipal roads to maintain to Municipal standards. The Township is predominantly agricultural in nature as defined by its physical characteristics and history but it is also now characterized as a residential area as many individuals are seeking to live in an area where countryside preservation and controlled development exist hand-in-hand with convenient access to job markets, hospital and schools.

The population is expected to grow at an average annual rate of 0.58% for a projected population of 7,504 by the year 2034. Like the rest of the Province of Ontario, the Municipality will see population shares by age shift, particularly through a sharp increase in the proportion of seniors, while the population under 15 will decline. The current population contains a substantial portion of individuals over the age of 40. However, the Township is expected to follow the overall trend in the County of Northumberland and the rest of the Province, with an increasing proportion of seniors.

The Township has a number of Hamlets (Burnley, Centreton, Fenella, Grafton, Lakeport, Roseneath, Vernonville, Eddystone, and Wicklow) geographically positioned throughout the whole Municipality. There is a significant number of business and commercial enterprises scattered though the whole Township that provide local services and products including a variety of highly specialized resorts and tourist destinations.

The geography of the Township can pose barriers to residents and visitors with disabilities. There is no public transit or dedicated taxi service within the Township. The mobility of residents, especially people with disabilities is affected by the distances between communities and the availability of services.

#### **Ontario's Accessibility Legislation**

The Accessibility for Ontarians with Disabilities Act, 2005 (AODA), which became law in 2005 builds on the progress made under the Ontario Disabilities Act (ODA). The AODA is made up of five Standards and a number of General Requirements. The Standards include:

Customer Service

And the Integrated Accessibility Standards Regulation (IASR)

- > Information and Communications
- Employment
- Transportation
- Design of Public Spaces

One of the general requirements under the IASR is for organizations to create a Multi-Year Accessibility Plan and to review and update it every five (5) years. As with the ODA, the Multi-Year Plan must outline an organization's strategy to meet the requirements under the IASR.

The plan will be guide by the Township's statement on Accessibility Standards.


#### **Statement of Commitment**


